The following questions have been raised. Answers are indicated in italics.

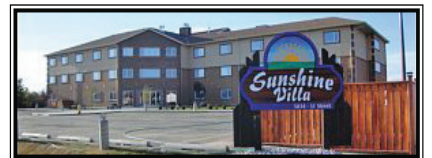
