NOTE: An elector may vote for the Councilor and School Trustee only in the Division or Ward in which they reside.

In order to vote, you must produce identification for inspection. The identification must be one or more of the following:

- a) Operator’s (Driver’s) Licence;
- b) Alberta Identification Card;
- c) Income or Property Tax Notice;
- d) Bank/Credit Card Statement;
- e) Utility Bill;
- f) Or any other approved ID authorized by the *Local Authorities Election Act*

as required by section 53 of the *Local Authorities Election Act*

NOTE: An elector may vote for the Councilor and School Trustee only in the Division or Ward in which they reside.

Requests for **SPECIAL BALLOTS** will now be accepted on the prescribed form in writing, by fax or in person. If you are not able to vote at an Advance Vote or on Election Day due to physical disability or absence from the County, you may request a Special Ballot (aka mail-in ballot). The ballot must be received by the Returning Officer by 4:30 pm on Friday, October 15 to be included in the count on Election Day.
