- The landowner shall submit a project application form to the County Office, 5120-50 Street Ryley AB, no later than May 31, 2020 for consideration by Council.
- Once approved, the project applicant is required to remove all fences, rocks, and debris from the project site. Rocks and other debris are not to be placed in the County road allowance.
- The landowner will be responsible for the burning/disposal of any brush piles created as a result of the backslope. Burning of brush will be subject to conditions of required fire permits.
- Upon completion, the area backsloped is to be kept free of weeds, brush, rocks and any other debris.
- The landowner is responsible for removing any fence prior to start of project and, if desired, is responsible for a new fence following completion of the project.
- The applicant shall submit a site sketch of the area to be backsloped.

Please note the following County responsibilities:

- The County will seed grass in the ditch following completion of the project providing the location is not to be utilized for crop production.
- The County is responsible for the location of utilities (One Call) for work completed by the County.
- The County will not commence the work until the request is approved by County Council.
- The County will not commence any work until a written agreement is in place between the County and the Landowner.
- Council approved backsloping projects will generally be completed after harvest and before freeze up.

Beaver County Council will limit the number of projects to a maximum of 10 (ten) per year, and only 1 (one) 800 meter (maximum) project per Landowner per year. All applications are subject to inspection by County staff before and after the commencement of any work for conformance with the County Backsloping Policy PW-002. If this backslope project is not approved in one calendar year, it will automatically be placed on the following year's project list for consideration by Council.


