

# 2021 Budget Highlights



On April 21, 2021, Beaver County Council approved the 2021 budget. This is the budget upon which the 2021 tax notices are based.

The 2021 budget meets all requirements of the *Municipal Government Act* – it includes current year operating and capital expenditures, payment of legislated requisitions, and is balanced.

The budget reflects the priorities of Council as identified during budget and strategic planning discussions, and considers what it heard from you – the resident and taxpayer.

It also reflects Council's desire to keep the mill rate increase as low as possible. Council was able to achieve **a reduction in the overall mill rate** in 2021 due to various fiscal restraint measures and a 2% increase in the assessment base.

### Understanding the tax rates

Your property tax bill includes tax (mill) rates for a number of different taxing bodies.

The municipal mill rate is the rate set by County Council to raise funds to provide all the municipal services (details on these services are provided throughout this brochure). In 2021, the municipal mill rate consists of 3 separate mill rates – General Municipal, BESC, and Policing.

#### General Municipal mill rate

In 2021, the general municipal mill rate did <u>not</u> increase. For small businesses, the mill rate decreased by 25%.

#### BESC mill rate

The mill rate established to pay the grant to the Beaver Emergency Services Commission (BESC) for fire protection and emergency management (disaster) services decreased by 29%.

#### Policing mill rate

2021 is Year 2 of the 5-year phased in program to costshare RCMP services with the Provincial Government. The 2021 amount of \$191,566 will require a mill rate of 0.1517 (79% increase). By the year 2024, the County will be required to pay \$418,016.


#### Other mill rates

In addition to the taxes raised to pay for municipal services, the total tax bill includes the taxes for seniors housing (Beaver Foundation), education, and assessment of designated industrial properties. The County is required to collect these taxes and then remit the funds directly to the Beaver Foundation and the Provincial Government.

In 2021, the Beaver Foundation mill rate decreased 1.6% over 2020.

The education mill rate decreased by 3.3% for residential and farmland properties and decreased almost 1% for non-residential properties.

The Designated Industrial Properties (i.e. DIP) mill rate, which only affects select industrial properties assessed by the Provincial Government, increased by 0.8% over the 2020 rate.



Unfortunately, the pandemic has added to the region's financial strain. The oil and gas sector is still struggling and loss of employment due to COVID-19 have made it difficult for some to pay their taxes.

In 2021, the County has estimated a 15% uncollectible tax rate (\$1,975,000). Without these taxes, the County cannot provide the services projected in the 2021 budget. To maintain the required cash flow, the allowance is funded by the Claystone Waste grant, reserves, and taxes.

# What's in the budget for me?

The 2021 budget includes the following projects. Sources of funding for these projects include reserves, grants, user fees, and the tax levy:

Total capital expenses including road construction in the 2021 budget are \$5,323,126. Funding sources include reserves, grants from the government and Claystone Waste, and taxes.

## Where is the money being spent?

The County's 2021 budget is a total of \$27,540,626. The amount spent in various areas (and funding sources) is as follows:

<sup>\*</sup> Major Financial Transactions consist of the Allowance for Uncollectible Taxes (\$1,975,000) and the debenture payment on behalf of the Beaver Foundation (\$261,419). The Beaver Foundation reimburses the County 100% of the amount paid.

# How are we going to pay for it?

To fund the budget, the County will access grants (\$5,487,790), reserves (\$5,942,266), and operating revenue (\$2,326,870). The balance (\$13,783,700) will be raised by taxes.

Almost all properties must pay property taxes. There are a few exceptions such as Federal and Provincial lands. On all taxable properties, the following <u>municipal</u> taxes are levied:

## How does the County partner to provide services to residents?

Collaboration with other organizations can be an efficient way for the County to provide services to its residents. The County has a long history of working with its urban neighbours (towns and villages) and other organizations to provide essential as well as quality-of-life services including fire protection and emergency management, family and community support services, and library and recreation services.

The 2021 budget includes \$2,238,752 for grants to various organizations. The County provides some direct funding, but in the case of services that are used by both rural and urban residents, it shares operating costs using a population-based formula.

The County has shared services agreements with each urban municipality to share operating costs. Each agreement specifies the services that are cost-shared (not all are cost-shared). In the 2021 budget, the County will spend in excess of \$1.5 million towards these partnerships.

Capital cost-sharing is determined on a request-by-request basis, other than BESC capital (fire protection), in which case the capital expenses are shared on a population basis.

The pandemic has been especially difficult for the County's valued service providers. Revenue from user fees and fundraisers has been drastically reduced or non-existent, while operating costs (such as utilities) must still be paid.

Due to wise fiscal management by non-profit organizations and urban municipal partners, the recreation and cultural facilities will remain open in 2021 (to the extent allowed by Alberta Health Services).

For recreation and library grants, the cost distribution in 2021 for each of the service areas is:
