NOTICE OF NON-STATUTORY PUBLIC HEARING PROPOSED AMENDMENT TO MUNICIPAL PARKS BYLAW

Bylaw No. 19-1074

The purpose of proposed Bylaw 19-1074 is to amend Bylaw No. 19-1070, the Municipal Parks Bylaw of Beaver County, to allow campground stays longer than 14 days.

Bylaw 19-1074 received first reading at the Regular Council meeting held June 19, 2019. The bylaw change would allow stays of unlimited duration (during the camping season) of up to 25% of the sites in County campgrounds. The County operates two campgrounds: Black Nugget Lake and Camp Lake. The bylaw would allow stays exceeding 14 days to a maximum of 25% for each type of site (25% of un-serviced sites, 25% of full-serviced sites, 25% of power sites, 25% of group sites, etc.). The normal daily campground charges would apply and there would be no "seasonal rates" available for longer term stays.

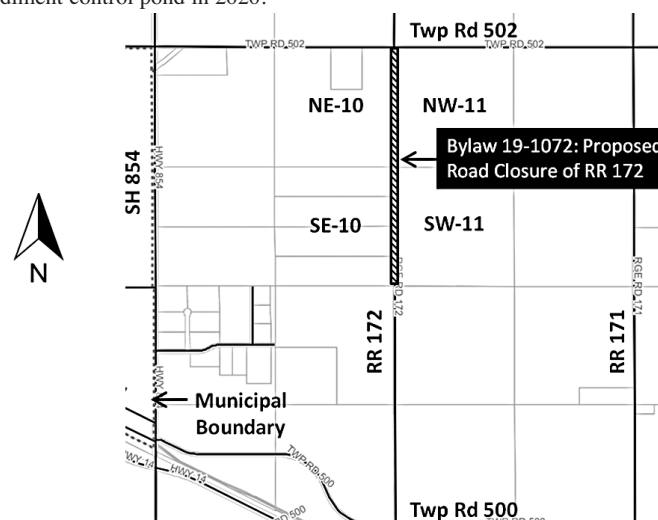
July 17, 2019, 10:30 a.m. FOR THE PURPOSE OF HEARING ARGUMENTS FOR AND AGAINST THE ROAD CLOSURE OF RR 172

Under the authority of the Municipal Government Act, Section 22, Beaver County Council is considering the passage of Bylaw 19-1072 to close to public travel for the intent to lease, a portion of undeveloped road allowance, described as follows:

Meridian 4 Range 17 Township 50

All that portion of the original government road allowance adjoining the west boundary of the NW ¼ 11-50-17-4 and SW ¼ 11-50-17-4
Excepting Thereout All Mine and Minerals.

The purpose of the road closure is to facilitate the ongoing landfill operation and development of a sediment control pond in 2020.



Beaver County Council will hear arguments for and against the proposed road closure at a public hearing scheduled for **10:30 a.m. on Wednesday July 17, 2019**, at the Beaver County Service Centre, 5120 – 50th Street, Ryley, Alberta.
